How much money needs to go to study in Canada

To study in Canada, a foreign student needs to be required to receive a study permit (Study Permit) and a TRV visa if the country is included in the list of visa countries. To receive Study Permit and visa, you will need to provide a standard package of documents that includes passports of all family members who are supported with you, confirmation of enrollment in an educational institution (Letter of Acceptance), an explanatory letter and the most interesting - compliance with the financial requirements for students. It is not surprising that the topic of finance is one of the most acute even among those who still think to go to study in Canada.

Let's deal with financial requirements that Canada presents to foreign students. One should only make a reservation that the compliance of the minimum requirements below will help you get permission to work and visa. To the real value of life in Canada, all these numbers have no relationship. How to calculate the number of financial resources required to receive Study Permit to calculate the following formula:

Number of people all provinces except Quebec

Only student

Payment for learning \* plus \$ 10,000 CAD for a period of 12 months (\$ 833 per month)

+ one family member

\$4,000 CAD for a period of 12 months (\$333 per month)

+ each subsequent family member (children)

\$ 3,000 CAD for a period of 12 months (\$ 255 per month)

If you are planning to study in Quebec:

Number of people Quebec

Only student

Payment for learning \$ 11,000CAD for a period of 12 months (\$ 917 per month)

+ one family member

\$ 5,100 for a member of the 18+ family for a period of 12 months (\$ 425 per month) or \$ 3,800 for a family member under 18 for a period of 12 months (\$ 317 per month)

+ each subsequent family member (children)

\$ 5,125 for a member of the 18+ family for a period of 12 months (427 per month) or \$ 1.903 for a family member under 18 for a period of 12 months (\$ 159 per month) Thus, if you plan to go to learn, for example, in Albert and take a spouse and one child with me, the formula will be the following: Pay for training + 10 000CAD + 4 000CAD + 3000CAD.

\* Payment for training - often the question arises - in the case of a biennial program, will it be enough to show funds only for the first year of study? Unfortunately, in this case you increase the risk of refusal, because the officer can decide that you do not have funds for the second year of study. In cases, if we are talking about longer programs, for example, four years old, you can not show funds for the entire period of study, but it is better to clearly explain from where they will take it in the future.

How to confirm the availability of funds for training in Canada

To actually confirm the availability of funds for training and accommodation in Canada for yourself and accompanying family members, you can provide some of the following documents:

Extract from your bank account for the last 4 months Confirmation of payment and accommodation Confirmation of a bank account in Canada in your name (if funds are already translated into Canada)

Confirmation of a loan for education from the relevant bank (if they took)

Decorated bank check in convertible currency

A letter from the sponsor or sponsoring organization confirming the intentions

Confirmation of scholarships if you got it.
